For conventional installation heavy duty underlay is recommended. Beaulieu Australia does not recommend the use of Hair Felt Underlay's. Seam Sealer must be used on all seams and cross joins. Chair mats are mandatory. Professional cleaning is recommended. Construction of this carpet may involve the occurrence of shift lines across the width of the carpet. Certain light sources shining across the carpet surface may emphasise these lines by forming shadow lines. This effect is not a manufacturing defect and will not detract from the carpets performance .

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law .
